

Online Storage layer




Providing storage to services in:


- MCloud,

Tiering of Storage based on Service Levels


- Tier 1.1 Storage used in the path of the Time-Critical operational suite;
- Tier 1.2 24/7 support for critical issues, with a 4 hours response;
- Tier 2 Sociable hours support;
- Tier 3 Next working day support.

Tiering of Storage






Tier 2 ~25 PB MARS ECFS **VolFDB** Scores ECcloud DB







Initial disk systems for the new Data Centre

- Tier 1.1
 - NAS[HA] (Highly Available NAS) for ECPDS and Eccharts.
 - Multiple NAS[SC] (Single Controller NAS) for the SAPP clusters.
- Tier 1.2
 - Multiple NAS[HA].
- Tier 2
 - Volume FDB (8PB), ScoresDB NAS[SC];
 - DHS mostly block storage (SAN):
 - Existing disk 10.6 PB (Retiring 2.5 PB, mix IBM and DDN, and moving 8.1 PB to Italy);
 - Initial temporary cache acquisition of 5 PB (2019), 5PB (2020) of disk storage;
 - Absorbed into normal DHS storage.
- Tier 3
 - NAS[SC] will be used for: Permanent Space, Project Space, VEEAM, backups.

Storage Performance and Tiering

• Tier 1.1

- Greater use of high performance storage, e.g. pure flash appliances with smaller capacity.
- Top end SAS HDDs where more capacity is required.
- Tier 1.2
 - Hybrid solution with flash and SAS HDDs.
- Tier 2 & Tier 3
 - High capacity storage systems utilising a mix of SAS and NL-SAS HDDs.

Procurement Strategy

- Storage Framework 262 est. late 2017 (for equipment and services):
 - Can purchase NetApp, IBM, Hitachi, Lenovo, HP, EMC, ...
- Industry day:
 - Explain storage needs;
 - Encourage resellers.
- Select new members who meet the necessary standards for Framework
 262 via Open Tender.
- Run mini competitions for new equipment/services under the framework.
- Only suppliers accepted onto the framework (existing and new) will be able to bid.

Timeline

- Storage Framework 262 est. late 2017;
- Reopening of Framework 262 on Q1 2019;
 - Open Tender to be published on ECMWF's website and OJEU;
- Selection to be completed by Q2;

 Mini competitions to be issued to suppliers approved for framework from Q3 2019:

- Functional requirements,
- Specific requirements.
- Delivery of new equipment from Q4 2019.
